

Privacy Policy

This Privacy Policy applies to the Personal Data collected and processed by FlatTurtle BV, with registered office at Schrieksesteenweg 108, 2221 Heist-op-den-berg and with enterprise number: 0843.961.762 (hereinafter "**FlatTurtle**", "**we**" or "**us**").

FlatTurtle deems the protection of privacy of the utmost importance. FlatTurtle wishes to inform you about the way it Processes your Personal Data, in accordance with the applicable data protection legislation and more specifically with the General Data Protection Regulation ("**GDPR**") and its relevant national implementing legislation. All capitalized terms that are not defined in this Privacy Policy shall have the meanings as ascribed to them in the GDPR.

This Privacy Policy describes your rights for you to make informed decisions and to exercise your rights when necessary. Please read this Privacy Policy very carefully.

1. Who Processes your Personal Data and how can you contact us?

FlatTurtle is responsible for the Processing of your Personal Data and shall act as a Controller in the context of the Processing activities described in this Privacy Policy.

Please note that we often act as Processor of our clients (e.g. when providing meeting booking and/or wifi management services). Please contact our clients directly if you would like to have more information regarding these Processing activities.

2. What Personal Data are collected and processed and for which Purposes?

FlatTurtle processes the following Personal Data for the following purposes:

4. Transfer of Personal Data outside the European Economic Area (EEA)

The European Economic Area ("EEA") includes the countries of the European Union, as well as Norway, Liechtenstein and Iceland.

Some of our third-party service providers may Process your Personal Data in countries outside the EEA. These transfers outside the EEA will only occur in accordance with applicable law (such as chapter V of the GDPR) (e.g. model contract clauses, binding corporate rules, code of conduct, adequacy decisions, etc.)

5. How are my Personal Data safeguarded?

FlatTurtle has developed appropriate technical and organizational measures, safeguards and assurances to Process your Personal Data in accordance with applicable Belgian and European regulations, in particular to protect your Personal Data against loss, misuse, or unauthorized alteration or destruction.

The measures taken by FlatTurtle, include:

- Restricting the access to systems containing Personal Data;
- Storing only the Personal Data strictly necessary to make the systems function (e.g., email addresses, name, encrypted passwords).

FlatTurtle makes thus all reasonable and appropriate efforts to protect the confidentiality of your Personal Data. Within FlatTurtle access to your Personal Data will only be granted on a need-to-know basis.

Despite the above measures taken by FlatTurtle, you should be aware that there are always risks associated with sending Personal Data over the Internet. The security and protection of your Personal Data can never be fully guaranteed.

6. What rights do I have?

If and in as far as provided for in the applicable Belgian and European legislation, you have the right:

- a) to receive confirmation as to whether FlatTurtle Processes your Personal Data and, where this is the case, to access the Personal Data that FlatTurtle Processes;
- b) to corrections by FlatTurtle, without undue delay, of any inaccurate or incomplete Personal Data;
- c) to have your Personal Data deleted by FlatTurtle;
- d) to obtain your Personal Data and to transfer them to another controller or processor;
- e) to obtain a limitation of the Processing of your Personal Data from FlatTurtle, to the extent possible subject to applicable Belgian and European regulations;
- f) to receive your Personal Data in a structured, common and machine-readable format;
- g) to object to the Processing of your Personal Data and the use of your Personal Data for direct marketing purposes.

If and to the extent provided for in the applicable Belgian and European legislation, you have the right to file a complaint with the competent supervisory authority should the Processing of your Personal Data violate the applicable regulations. 7. Consent for disclosure

You acknowledge that we may disclose your Personal Data if this is required by law, or if FlatTurtle determines in good faith that such disclosure is required in order:

- a) to comply with any pending judicial inquiry, judicial order or litigation;
- b) to respond to claims against FlatTurtle regarding Personal Data that violate any rights of third parties;
- c) to safeguard the rights, property and safety of FlatTurtle, its employees, users, and the general public.

FlatTurtle may disclose your Personal Data to competent police or judicial authorities or other official government authorities if FlatTurtle deems this useful or necessary, in its sole discretion, for the investigation of fraud, intellectual property infringement or any other harmful activity, or if FlatTurtle reasonably suspects that such activity may expose FlatTurtle or you to any liability.

8. Liability

If FlatTurtle has legitimately transmitted your Personal Data to a third party (not being a Processor or subprocessor), FlatTurtle shall not be liable for any unlawful Processing or unlawful use by that third party.

9. Applicable law and competence clause

This Privacy Policy shall be governed, interpreted, and implemented in accordance with Belgian law, which applies exclusively in the event of any dispute.

The Belgian courts and more specifically, the courts of Antwerp (division Antwerp) are exclusively competent to decide on any dispute that may arise from the interpretation or implementation of this Privacy Policy, without prejudice to the consumer's right to present a dispute before the competent court on the basis of a mandatory statutory provision.
